## The New EU Regulation 2019/1020/EU on Market Surveillance and Compliance of Products

Amazon requires sellers to comply  
with the New Surveillance Regulation!

### Key Facts on EU Surveillance Regulation 2019/1020/EU:



The Regulation places specific focus on e-commerce and online trade and is applicable to online sellers across Europe



The Regulation requires compliance for the following products: toys, EMC/LVD, Pressure Equipment & Transportable Pressure Equipment, Machinery, Personal Protective Equipment, Radio Equipment, GPSD.



The Regulation will enter into force on the 16th of July 2021
